EEPC India is the premier trade and investment promotion organization in India. It is sponsored by the Ministry of Commerce & Industry, Government of India and caters to the Indian engineering sector. Set up in 1955, **EEPC India** has a membership base of over 12,000, of which 60% are SMEs.

EEPC India organizes a large number of promotional activities such as buyer-seller meets in India and overseas, trade fairs, India Pavilions and information booths. **EEPC India** facilitates sourcing from India and helps and encourages SMEs to raise their engineering and product standards to international levels. EEPC India is a full member of the French-based UFI (The Global Association of the Exhibition Industry) and its annual show – IESS is an 'UFI Approved International Event'. Also, EEPC India has received the BMO accreditation of the Quality Council of India (QCI)-NABET (National Accreditation Board for Education and Training is one of the constituents of the Board of Quality Council of India).

The growth of engineering goods exports from India from US\$10.8 million in 1956-57 to US\$76.2 billion in 2017–2018 has been because of **EEPC India's** constant efforts to promote exports by encouraging exporters to diversify their products and enter new markets.

PRODUCT PANELS

Keeping 'Engineering the Future' as the motto, EEPC India serves as the reference point for the Indian engineering industry and the international business community in its efforts towards establishing India as a major engineering hub in the future. It has organised similar kinds of products under one panel and has 42 such panels ranging from machinery for heavy industries, electrical machinery, machine tools, iron and steel, sanitary and industrial castings, railways and related products, forgings, fasteners, pumps, auto parts, industrial equipment, bicycle parts, steel pipes and tubes, etc. It regularly conducts panel meetings over video conferencing to understand the requirements of the exporting fraternity in that product group from all regions.

EEPC was recently appointed lead agency for the Defence and Medical Devices sectors.

EEPC India acts as an interface between exporters and various government agencies such as the Cus-

toms, Excise, Reserve Bank of India, Export Credit Guarantee Corporation (ECGC), Export Import Bank of India, shipping lines, and freight forwarders associations. EEPC India is in constant touch with the Directorate General of Foreign Trade (DGFT), Government of India, for clarification on matters relating to policy and procedures of the Foreign Trade Policy.

EEPC India brainstorms on various issues and sends its suggestions with respect to Foreign Trade Policy, Union Budget, Credit Policy and various other issues pertaining to exports. The Council has played active role in bringing about amendments in government policies in favour of its members.

EEPC India collaborates with Tenders Info, the largest and most comprehensive source of international tenders, bids and RFP's for access to over 20,000 live contacts.

ROUND-THE-YEAR EXPOSURE TO OVERSEAS EXHIBITIONS

EEPC India organises large overseas fairs and promotional activities such as Buyer Seller Meets, and India Pavilions at overseas trade fairs. EEPC India's star overseas events are **INDEEs** and **Partner Country Shows**.

INDEE: INDEEs are large exhibitions with around 100 Indian exporters. 38 INDEEs have been held so far – Singapore, Indonesia, Malaysia, Kenya, Nigeria, Sri Lanka, Egypt, Venezuela, the UK, Australia, Ethiopia, Brazil, Kazakhstan, Mexico, South Africa, Russia, China, Colombia, Vietnam, Myanmar, Iran and Bangladesh, etc. INDEE completes 41 years since 1977 when the first edition of INDEE took place in Singapore. INDEE has covered 26 countries which underscores its immense popularity.

Buyer-seller Meets: EEPC India regularly organises Buyer-Seller Meets overseas as well as in India.

Product-specific shows: EEPC India also organises product-specific shows called India Pavilions at international fairs such as Hannover Messe, Automechanika, Asia Pharma, Autotech, Mactech, JIMEX, etc.

Partner Country/Lead Agency status: EEPC India has been the lead agency or official organiser while organising several important fairs where India was given 'Partner Country' status.

International Engineering Sourcing Show (IESS): To encourage global partnerships with India, EEPC India organizes the International Engineering Sourcing Show, a prime partnership event that acts as a conduit between Indian and overseas engineering firms. Recognized as the only sourcing event in India, it showcases the latest technologies and is a meeting place for global buyers and sellers. The seventh edition of IESS would see two special attractions – India Subcontracting Expo 2018 and the Technology Pavilion.

EEPC India (formerly known as Engineering Export Promotion Council) was set up in 1955 under the sponsorship of the Ministry of Commerce and Industry, Government of India to promote the exports of engineering goods, projects and services from India.

Now, EEPC India has over 12,000 members from the entire spectrum of the Indian engineering industry – large corporates, star trading companies, small and medium scale units (SME), trading companies and business and trade associations.

EEPC India plays a critical role in the promotion of engineering exports from India through its various offices in India and acts as an interface between exporters and various government agencies such as the Customs, Excise, Reserve Bank of India, Export Credit Guarantee Corporation (ECGC), Export Import Bank of India, shipping lines, and freight forwarders associations. EEPC India is in constant touch with the Directorate General of Foreign Trade (DGFT), Government of India, for clarification on matters relating to policy and procedures of the Foreign Trade Policy.

EEPC India has been the face of Indian engineering exports over a span of 63 years when India grew from a meagre US\$10 million engineering exporting nation in 1955 to \$76.2 billion in 2017-18 - the largest share in India's exports.
