

Payment terms

- Exhibitors need to pay via NEFT or Payment Gateway for participation charges.

- Space shall not be confirmed by EEPC India until and unless full payment is made on that account by the exhibitor and consequently no possession of space shall be given to the exhibitor concerned.
- No request for cancellation of space and refund/adjustment shall be accepted by EEPC India once a booth is booked.


